Benguet Corporation (BC) today disclosed that its Benguet Gold Operations in Itogon, Benguet, has been issued by TUV Rheinland®, an independent evaluation and certification service body, an ISO 14001:2015 Certification on Environmental Management. This comes following an eight months intensive audit/review of its mining operation. ISO 14001:2015 is an internationally accepted standard for environmental management system. With its earlier disclosure that its wholly owned subsidiary, Benguetcorp Nickel Mines, Inc. (BNMI), has also been issued ISO 14001:2015 Certification by TUV Rheinland®, BC and BNMI are the first mining companies in the Philippines to be certified under the 2015 version. The certification makes BC and BNMI fully compliant with the requirement of DENR DAO No. 2015-07 which mandates existing mining firms to secure ISO certification on environmental management on or before May 2016.
