

Benguet Corporation (the "Company") today disclosed the following matters that were taken up during the regular meeting of its Board of Directors (the "Board"):

1. The Board approved the early retirement of Mr. Benjamin Philip G. Romualdez as President & Chief Executive Officer of the Company for health reason, and his resignation as Director and Vice Chairman of the Board of Directors, effective August 23, 2017. To replace Mr. Romualdez, the Board elected Mr. Leopoldo S. Sison III as the President & Chief Executive Officer of the Company and appointed him as a Director in the Board of Directors. Before his election/appointment, Mr. Sison was previously the Senior Vice President for Nickel Operations. In January 27, 2014, Mr. Romualdez took a leave of absence from the Company which was extended indefinitely until his early retirement.
