

1. Benguet Gold Operation, Antamok Gold Operation and Ampucao Copper-Gold Project – The Company is the applicant for Exploration Permit Application (EXPA) No. 0122-CAR (former APSA No. 009-CAR). The APSA was converted to EXPA pursuant to Section 9 of the Department of Environment and Natural Resources (DENR) Administrative Order (DAO) No. 2021-25. The MGB-Cordillera Administrative Region (CAR) endorsed the application to MGB-Central on April 20, 2022. The EXPA is under evaluation by MGB-Central.
 2. The Company's FTAA application in the Province of Ilocos Norte denominated as AFTA-000003-I is under evaluation by MGB-Central.
- B. List of valid mining claims, including a disclosure of all items/encumbrances:
1. Pantingan Copper-Gold Project (MPSA No. 154-2000-III). The Company holds an operating agreement with MPSA holder Balanga Bataan Minerals Corporation (BBMC). The project is under exploration period.
 2. Zamboanga Gold Project – The Company holds an operating agreement with Orelina Mining Corporation (OMC) with application denominated as EXPA No. 156-IX (former APSA No. 000015-IX). The APSA was converted to EXPA pursuant to Section 9 of DAO No. 2021-25. The MGB Regional Office (RO) No. IX endorsed this to MGB Central Office on December 2, 2022. The EXPA denominated as EXPA No. 156-IX is under evaluation by MGB Central.
