
Benguet Corporation (PSE: BC), the country's oldest publicly-listed mining company, today approved the issuance of its 2025 audited financial statements reflecting strong financial performance. BC posted a consolidated net income of ₱760 million for the year ended December 31, 2025, a 74% increase over the ₱436 million recorded in 2024. The Board of Directors simultaneously declared cash dividends for all stockholders, directly rewarding them for their continued trust in the Company.

The Company delivered consolidated revenues of ₱3.31 billion in 2025, up 38% from ₱2.39 billion the prior year. This marks the Company's most significant top-line growth in recent years, driven by improved operational output across its core gold and nickel operations, combined with higher commodity prices.

Basic earnings per share climbed 74%, from ₱0.61 in 2024 to ₱1.06 in 2025, reflecting not just revenue growth but the quality and sustainability of BC's earnings. Consolidated net income of ₱760 million represents a 74% improvement over 2024, with margin expansion driven by operational efficiency and a continued focus on optimum capacity utilization.
