Benguet Corporation (the "Company") hereby discloses the following matters taken up and approved by the Board of Directors (the "Board") in today's regular board meeting:

1. Upon endorsement of the Audit Committee, the Board approved the Audited Parent Financial Statements (APFS) and Audited Consolidated Financial Statements (ACFS) of the Company as of year ended 31 December 2025. The Company posted consolidated revenue of ₱3.31 billion, 38% higher than the consolidated revenue of ₱2.39 billion in 2024. Consolidated net income for 2025 amounted to ₱760 million, 74% higher than ₱436 million in 2024. Likewise, basic earnings per share increased by 74%, from ₱0.61 per share in 2024 to ₱1.06 per share this year.

The Board also approved and authorized the issuance of the Company's 2025 APFS and ACFS as audited by Sycip Gorres Velayo and Company;


2. The Board noted the designation of Engr. Deogracias P. Halog, AVP for Technical Operations as Officer-In-Charge/General Manager of Benguet Gold Operations (BGO) replacing Engr. Valeriano B. Bongalos, Jr. who retired on February 28, 2026, and approve his authority to manage and supervise BGO, which include authority to sign and execute contracts, agreements and other documents.
